1 Briefly describe the organization's mission: JustWorld International acts as a catalyst for positive change in the developing world by working with local partner organizations to provide basic education, nutrition, health, hygiene, and vocational programs for children in impoverished (continued on Schedule O)

4a (Code:) (Expenses \$ 186,963. including grants of \$ 186,963.) (Revenue \$) In Cambodia - The organization works hand in hand with the People Improvement Organization to fund and support the operation of two schools, Borey Keila and Stung Mean Chey, in Phnom Penh, Cambodia. The schools offer classes for children from kindergarten through ninth grade, a hygiene awareness program, on-site medical services, and a nutrition program for 800 children in severely impoverished regions of the capital city.

Key achievement: education - 97% of grade 6 students passed their entrance examination for public high school and the overall number of high school students increased from 50 to 85. 80% of all Pio students graduated to the next level of study.

4b (Code:) (Expenses \$ 57,277. including grants of \$ 57,277.) (Revenue \$) In Guatemala - The organization works with Asociacion Los Patojos Suenos e Ideas en Accion (Los Patojos) in Jocotenango, Guatemala, to operate a free health clinic and a community center that provides children and young adults with nutritious meals, tutoring, and after-school activities for more than 275 children. Additionally, Los Patojos runs ballet, breakdancing, theater, journalism and photography programs as well as vocational training projects for dozens of young adults.

Key achievement: nutrition - 675 meals were served over 11 months in 2013, 300 more than in 2012 as the number of participants increased from 70 to 100 students.

4c (Code:) (Expenses \$ 42,981. including grants of \$ 42,981.) (Revenue \$) In Honduras - The organization supports a mobile library literacy program through the Honduran Charity Compartir. The mobile library provides access to books, reading programs and scholastic support to more than 2,755 children in remote communities with exceptionally limited access to traditional education. Students also participate in theatre and journalism workshops, attend field trips to local museums, and organize community outreach. This support helps to develop youth literacy, self-expression, and social integration.

Key achievement: Leadership - 95% of the youth journalism group (30 members) visited local media outlet Canal 10, a national educational TV programmer. They also visited Radio Nacional of Honduras, which aired
