(Revenue \$) Honduras- Asociacion Compartir More than 3,200 children benefitted from the mobile library activities and 200 children had direct contact with a book for the very first time in their lives. 2,083 boys, girls and youth participated in library activities such as reading, film, storytelling, dramatizations, expositions, and research projects. Each day, leaders emerged and the directors were excited to see the great potential that exists within the communities. Without JustWorld, they would not have these opportunities to succeed and become good citizens. Nutritious snacks were provided to more than 7,000 children and youth who participated in the activities generated through the JustWorld project (Community Library, Mobile Library and workshops for painting, choir, flute

4b (Code:) (Expenses \$ 258,981. including grants of \$ 253,243.) (Revenue \$) Guatemala- Los Patojos Los Patojos' alternative education program was nationally recognized and became a full-time school serving 170 students from Pre-Kindergarten through 6th Grade. Los Patojos served 38,080 lunches and with the addition of the new centre, the nutrition program was expanded to serve breakfast to students as well. Students are now receiving two meals each day at Los Patojos. The on-site physician, Dr. Hector Valle, served more than 1,287 patients in the clinic. Los Patojos officially organized their arts programs into the "Institute of Cultural Action Paulo Freire". 206 boys and girls participated in workshops including stop motion, graphic arts, music, journalism, juggling, and dance and 50 of the youths participate Monday through

4c (Code:) (Expenses \$ 202,977. including grants of \$ 202,975.) (Revenue \$) Cambodia - People Improvement Organization (PIO) JustWorld supported 800 students in Kindergarten through 6th Grade. 90% of students in 6th Grade passed their high school entrance exams, which is well above the average of other contributing schools, and many of the students who are now in high school placed in the top 25% of their class. All students supported by JustWorld received uniforms, books, and school supplies. All students received a nutritious lunch each school day comprised of rice, vegetables and meat or fish as well as 5 kilograms of rice per month. The PIO nurse cared for approximately 400 students each month. 37 students participated in the Apsara dance classes. They trained every Sunday and performed for a number of visiting schools as well as Maybank (continued on Schedule O)
